- 1. Admission fee:** Its onetime non refundable fee paid at the time of admission or over change of programme. Admission fee is a one-time fee paid at the time of admission and is not refundable. The admission fee or any part of it will not be Refunded or transferred even if after payment; the child does not start attending school.

- 2. Annual Education fee:** Annual education fee is payable in two equal installments in March and November. This includes:
 - 2.1. Tuition Fee:** Tuition fee is paid in the month of March and November
 - 2.2. Technology and resources fee:** This involves upgrading and connecting students’ personal laptops with the school resource centre through Wi-Fi, installing educational material for class room studies and references.
 - 2.3. Books and Stationery:** This includes one set of Books, Notebooks, eBooks’, CD & stationery items issued to student at the beginning of the academic year. The set is sufficient for one year requirements. In case of extra or any additional requirements student will be billed accordingly. Since these books are imported thus it may not be available immediately.
 - 2.4. Examination fee:** Examination fee depends on number of subjects opted by the student and RBI rate of exchange / conversion with international currency.
 - 2.5. Breakfast charges:** This includes breakfast which is served to all children.
 - 2.6. Educational Visits:** Local educational visits with consent from parents
 - 2.7. Activity Fee:** Regular Day to day indoor and outdoor activities which are part of classroom teachings

- 3. Supplementary fee (Transport, Lunch, Outstation field trips, Special education needs):** This is optional fee and depends upon child’s needs.

TERMS AND CONDITIONS

Fee Payment

- Fee payments can be made by RTGS*/NEFT*/Cheque/DD (drawn in favour of 'Neev Academy Yemalur'), or by credit card (with an additional levy of 2% on the total amount payable).
- Admission Fee is a one-time fee paid at the time of admission and is not refundable under any circumstances. The admission fee or any part of it will not be returned even if after payment, the child does not start attending school.
- Annual Education fee would be payable in two equal installments. The Term 1 fee would be payable between 15th to 30th March 2018 and the Term 2 fees would be payable in the 1st week of November 2018.
- In case of non-payment of tuition fee, the school will attempt to contact the parent, through email or phone number furnished by the parents at the time of admission, but if unable to contact, will have the right to cancel the admission, once the first 5 working days of the term or the stipulated number of days after admission have passed.
- Annual Education fee and supplementary fee is non-refundable under any circumstances.

Withdrawal and cancellation of enrolment

- Admission fee is onetime fee paid and is not refundable under any circumstances.
- In all cases where a child's admission is cancelled, the school will owe nothing to the parents. All Admission fee, Annual Education fee & Supplementary fee will be forfeited.
- Neev Academy reserves the sole right to cancel the admission of a child for non compliance with Neev School's policies.

Following are some of the conditions for forfeiture of fees upon cancellation of admission of a Child at Neev Academy (this is only indicative and not exhaustive – the spirit of these points will be considered when cancelling the admission of a child, and Neev Academy will carry out such an action only under exceptional situations)

- Non-payment or late payment of fee & dues as per the fee policy.
- Abusive parent behavior during visits & interactions with school management, staff member, support staff or students of Neev Academy.
- Children that are physically violent and destructive to school property or the property of other children or adults in the school environment are liable for disenrollment without any notice. The complete discretion of such an action will lie with the school authorities.
- Any action, situation or circumstances which impact the school's image or smooth functioning.

Policy and Guidelines

All policies and guidelines for collection of school fee have been approved by the Governing council. In all cases, the school will strictly adhere to these policies. All fees are subject to periodic revision.
